

## Examination fees and provision of services 2020

A fee is payable for each candidate entered for an examination, class award, solo performance award, presentation class or demonstration class.

The fee is for the provision of an examination service provided by the Royal Academy of Dance. The RAD undertakes to send an examiner to conduct, assess and/or observe the examination, assessment or class at a time and location which the RAD will determine (for examinations in RAD Approved Venues), or at a time which the RAD will determine and at a location which the Applicant will determine (for examinations in Approved Examination Centres).

### Notes to the fees tables

Fees Tables are published annually by the Royal Academy of Dance, a charity registered in England and Wales No 312826 on behalf of the worldwide Royal Academy of Dance Group, and in accordance with the requirements of the examinations regulators.

- 1 In certain countries, fees may include a value added tax or general service tax. The Fees Table indicates which fees are inclusive of a tax; the table below indicates the percentage added, and the Tax Registration Number under which the fees are levied. The Academy passes over the value added tax or general service tax to the appropriate authorities.

- 2 During the year, examination fees and other fees formerly outside the scope of such taxes may become subject to tax in certain countries, either due to changes in the tax regime of the country, or because a threshold over which taxes must be included is breached. The Academy reserves the right to amend fees where such tax changes take place during a calendar year, or where circumstances, such as the introduction or devaluation of a currency, dictate.
- 3 The RAD publishes examination fees for countries where there is an established provision of services and where the scheduled examination session exceeds seven days. Applicants requesting an examination service in a country where the Academy has no presence, or where the area is considered to be sufficiently remote to render a tour uneconomic, or where the number of examination days is below the minimum of seven days, will normally be required

to pay for the full cost of the service. Please contact the Examinations Department at RAD headquarters for more information.

- 4 The Member fee for vocational graded examinations is applicable only if the candidate is a member at the time of receipt of the application; the candidate cannot apply for membership at the same time as entering.
- 5 Where candidates are entered for examinations in Approved Examination Centres (AECs - teachers' own studios) and there is less than the published minimum amount of examining, the Applicant is required to pay the minimum fee level as quoted in the Fees Table.
- 6 For information about surcharges made for late entries, please see Section I of *Specifications*. Late entries are not normally accepted more than 14 days after the closing date.
- 7 Entry forms returned to the Applicant requiring amendment or completion and any changes made to entries received after the closing date will incur a fixed surcharge as shown.
- 8 Applicants whose payments are returned by the bank will incur a fixed surcharge as shown each time a fee is rejected. Applicants whose credit card payments are refused by the credit card company will incur a handling fee equivalent to that charged by the credit card company.
- 9 For information about withdrawals and refunds, please see Section I of *Specifications*.
- 10 Fees for replacement certificates (or extract from the Register of Examinations for examinations processed in London and

taken prior to September 2003), result forms, assessment reports, medals and bars are shown in the Fees Table.
